

Act, 1956 restricting the number of admissions to 2(Two) students per year.

The Board of Governors further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

The Board of Governors further decided to defer the consideration of recognition of MS(Orthopaedics) qualification till a clarification is received from the institute as to how the candidate appears for examination after 2 years while the duration of degree course is 3 years and degree course has been permitted in 2009.
